Minutes

1. Introductions

The meeting was called to order at 3:05 pm by CS Jordan. Everyone introduced themselves and quorum not was established.

• CS Jordan noted that the final meeting of the Needs Assessment work group will be tomorrow, 3-5pm at Shanti, 730 Polk St #3.

6. HCAP Report

- Jeremy Tsuchitani-Watson updated the Committee on the HIV Consumer Advocacy Project (HCAP) report:
 - He reported on a number of cases with Service Categories including Housing, Dental,
 Ambulance/Outpatient, Psychosocial Support, Emergency Financial Assistance and Non-Medical Case Management.
 - He noted that there were 19 new cases in August.
 - o Between March and August 2018, the highest number of cases was in the Housing service category, with 20 cases (or 29% of all cases). The next highest was Medical Case Management with 10 cases (14%), followed by Ambulance/Outpatient with 9 cases (13%).
 - o CS Jordan commented on this month's high number of cases. He commended Jeremy for averting an eviction this month.
 - Jeremy responded: March, April and August had the largest amount of cases. He thinks last August also had a high number of new cases.

7. Getting to Zero Update Review

8. Needs Assessment Update

- CS Jordan reported on the progress of the 2018 Needs Assessment.
 - The Needs Assessment Work Group is meeting tomorrow, Thursday September 6th from 3-5pm.
 The meeting will take place at Shanti, 730 Polk St. 3rd floor.
 - o He reviewed the survey data of initial trends. He noted that it is about 2/3 completed, but it will give you an idea of what the data looks like this year.
 - The other major piece is qualitative data which is from interviews.
 - Three of the biggest trends were issues surrounding mental health, mobile services for case management and housing.
 - The next step is to cross tab and pull out specific information by gender, race and modes of substance use.
 - He will also put together interview notes and draw a series of conclusions and next step recommendations.
- CM Knoble asked if we ever look at the trends over the years.
 - o CS Jordan responded that there is a trends document available on the website. It was put together about two years ago.

9. COLA Update

- CS Jordan announced:
 - o He is in communication with Huckleberry Youth Services about setting up a Youth COLA.
 - o There is also the possibility of doing a PrEP COLA at Strut.
 - o They're hoping to do a transwoman COLA at the end of the year.

10. Resource Allocation- VOTE

- The group discussed funding scenarios for Ryan White resource allocation.
- The group choose to abstain from the vote because of low attendance.
