#### Ryan White (RW) Part B: HIV Care Program (HCP)

- HCP Management Memo 15-02, dated March 10, 2015, was distributed to HCP Contractors to update them on the requirement for Needs Assessments and Service Delivery Plans.
- HCP Management Memo 15-03, dated March 10, 2015, was distributed to HCP Contractors to inform them of the submission requirements for Quality Management (QM) Plans and update them on the revised QM indicators.
- HCP Management Memo 15-04, dated March 10, 2015, was distributed to HCP and Minority AIDS Initiative (MAI) Contractors to clarify the requirements for submission of the annual Early Identification of Individuals with HIV/AIDS (EIIHA) Plan.

### RW Part B: AIDS Drug Assistance Program (ADAP)

- ADAP Management Memo 2015-04, dated February 27, 2015, was distributed to ADAP Enrollment Workers (EWs) to inform them of the addition of atazanavir 300 mg/cobicistat 150 mg (Evotaz<sup>™</sup>) tablets and darunavir 800 mg/cobicistat 150 mg (Prezcobix<sup>™</sup>) tablets to the ADAP formulary.
- ADAP Management Memo 2015-05, dated March 13, 2015, was distributed to ADAP EWs to inform them of updates regarding Covered California Open Enrollment.
