### Report to San Francisco EMA HIV Health Services Planning Council February 2015

## Office of AIDS Division/Cross Branch Issues

On January 9, 2015, Governor Brown provided his 2015-16 budget proposal to the legislature. Under this proposal, the two Office of AIDS (OA) programs that receive state General Fund for local assistance are the HIV/AIDS Surveillance program and the HIV Prevention program.

- There are no changes proposed in the \$6.65 million General Fund local assistance support for the HIV/AIDS Surveillance program.
- There are no changes proposed in the \$2.85 million General Fund local assistance support for the Prevention program.
- There is no General Fund support for the AIDS Drug Assistance Program (ADAP) local assistance in the Current (FY 2014-15) and Budget Year (FY 2015-16) and there are no new major ADAP policy changes included in the proposed budget.

The FY 2015-16 Governor's Budget also includes an increase of five permanent positions and \$536,000 in ADAP Rebate Fund (Fund 3080) expenditure authority at the OA to perform a secondary review of eligibility documentation for all ADAP clients as required by the Health Resources and Services Administration (HRSA). This will ensure program integrity by avoiding potential fraud and abuse.

### Ryan White (RW) Part B: HIV Care Program (HCP)

- On January 22, 2015, the HIV Care Branch conducted an informational teleconference for contractors to review the revised HCP and Minority AIDS Initiative (MAI) Progress Report form, which is available on the OA website at <u>www.cdph.ca.gov/programs/aids/Pages/HCPForms.aspx</u>. Contractors who were unable to participate may contact their HCP Program Advisor with any questions about the Progress Report. The submission deadline for the Progress Report is February 27, 2015.
- The HIV Care Branch's monthly Best Practices teleconferences for RW Part B Service Providers will now be conducted quarterly. A Best Practices teleconference was held on February 4, 2015. The topic was the Early Intervention Services (EIS) service category, in which OA provided an overview of EIS and a RW contractor described their EIS program.
