



California Department of Public Health (CDPH), Office of AIDS (OA) Monthly Report July 2018

This report is organized to align the updates with Strategies from the Laying a Foundation for Getting to Zero: California's Integrated HIV Surveillance, Prevention, and Care Plan (the Plan). In April 2018, a Getting to Zero Baseline Report was released with new baseline measures for each Plan Objective, a description of formative activities, and a summary of next steps. Strategy A: Improve Pre-Exposure Prophylaxis (PrEP) Utilization

Pre-Exposure Prophylaxis Assistance Program (PrEP-AP)

- On June 21, 21 enrollment sites received their go-live date of June 25, to begin enrolling uninsured and insured clients into the PrEP-AP.
- As of June 21, there are 134 PrEP-AP enrollment sites.
- The OA webpage has been updated to include tools to assist enrollment workers in enrolling uninsured and insured clients in the PrEP-AP. These resources, along with job aids and policy documents, are available in the AIDS Drug Assistance Program (ADAP) Enrollment Worker SharePoint.
- As of June 21, OA has executed 20 contracts covering a total of 33 clinics who currently make up the PrEP-AP Provider Network:

Strategy F: Improve Overall Quality of HIV-Related Care

In July and August 2018, the HIV Care Branch will host two, two-day trainings for HIV Care Program contractors, one in northern and one in southern California. The training will discuss changes coming to the HIV Care Program (HCP), such as the Standards of Care and a financial eligibility requirement. OA will provide an overview of these changes, discuss implementation, and answer questions during the training. An email invitation will be sent to HCP Contractors soon, requesting they attend one of the two trainings. The training is only for HCP Contractors, not sub-contractors. Each HCP Contractor must send one attendee, and can send up to two.

Strategy J: Increase Rates of Insurance/Benefits Coverage for PLWH or on PrEP

Expansion of the Medicare Part D Premium Payment (MDPP) Program

• Effective June 14, 2018, the MDPP Program benefits have expanded to include payment of Medigap premiums and outpatient medical out-of-pocket claims up to a client's annual out-of-pocket maximum.

Employer Based Health Insurance Premium Payment (EB-HIPP) Program

- Effective May 24, 2018, new and existing ADAP clients who are currently enrolled in an employer-based health insurance premium plan may receive premium assistance for the client's (employee's) portion of their employer-based insurance premiums, if eligible.
- The EB-HIPP Program will pay medical and dental premiums, if eligible. If a vision premium is included in the medical or dental premium, the client will have their vision subsidized.
- The EB-HIPP Program will also pay the client's outpatient medical out-of-pocket claims up to a client's annual out-of-pocket maximum, if eligible.

Strategy K: Increase and Improve HIV Prevention and Support Services for People Who Use Drugs

As part of the FY 2018-19 state budget, the California legislature enacted a trailer bill that included the following changes to laws governing CDPH's ability to authorize syringe exchange programs (SEPs) and provide them with supplies. These changes went into effect on June 27, 2018:

- The January 1, 2019, sunset on CDPH's power to directly authorize new SEPs was repealed.
- The 90-day public comment period for review of new SEP applications was cut from 90 to 45 days.
- The legislature added a new section to the Health & Safety Code, which will allow an SEP already authorized by CDPH to request approval for changes to service locations, hours, or services model (e.g. mobile vs fixed site). The request will not be subject to the public comment requirements for new SEPs, and CDPH will respond to the request within 30 days.
- The state drug paraphernalia law was amended to allow CDPH, through the Syringe Exchange Supply Clearinghouse, to purchase and distribute any materials deemed necessary for disease prevention or safety. This change will allow OA to expand the Clearinghouse catalog to include materials needed for safer injection, such as "cookers" (bottle caps used for dissolving drugs) that were not previously available.
- The requirement that health officers report biennially (every other year) about SEPs was retained, and statute did not revert to the previously enacted annual reporting requirement.

General OA Updates

- Governor Brown signed the Enacted Budget on June 27, 2018.
