



California Department of Public Health (CDPH), Office of AIDS (OA) Monthly Report September 2018

This report is organized to align the updates with Strategies from the Laying a Foundation for Getting to Zero: California's Integrated HIV Surveillance, Prevention, and Care Plan (Integrated Plan). Strategy A: Improve Pre-Exposure Prophylaxis (PrEP) Utilization

<u>Pre-Exposure Prophylaxis Assistance Program (PrEP-AP)</u>

- On August 13, OA reached out to five sites informing them of their PrEP go-live date of August 20. Sites were provided with a PrEP-AP Enrollment Site Approval Letter and resources to assist the enrollment site in enrolling applicants.
- As of August 27, there are 149 PrEP-AP enrollment sites and OA has executed 25 contracts covering a total of 38 clinics that currently make up the PrEP-AP Provider Network:

Strategy H: Improve Integration of HIV Services with Sexually Transmitted Disease (STD), Tuberculosis, Dental, and Other Services

OA would like to congratulate Orange County Health Agency (OCHA), 17th Street Testing, Treatment, and Care Clinic for winning a Center for Quality Improvement and Innovation (CQII) 2018 Quality Award. Every year the Health Resources and Services Administration-funded CQII recognize the outstanding work of Ryan White HIV/AIDS Program recipients and consumers that have shown either exemplary performance or leadership in some aspect of quality management. OCHA received the Leadership in Quality award for the pilot project they did with the California Ryan White Part B Clinical Quality Management Program and California Prevention Training Center. The project was to increase extra genital gonorrhea and chlamydia screening (three-site testing) among men who have sex with men. Lessons learned from the implementation of this project have been valuable in framing how the CDPH will continue to support STD screenings for people living with HIV.

Strategy J: Increase Rates of Insurance/Benefits Coverage for PLWH or on PrEP

Employer Based Health Insurance Premium Payment (EB-HIPP) Program

- New and existing AIDS Drug Assistance Program (ADAP) clients who are currently enrolled in an employer-based health insurance premium plan may receive premium assistance for the client's (employee's) portion of their employer-based insurance premiums, if eligible.
- CDPH developed a brochure and talking points to provide to clients to assist them in speaking about and answering questions from employers regarding the EB-HIPP Program.

Medicare Part D Premium Payment (MDPP) Program

 The MDPP Program pays monthly Medicare Part D premiums or Medigap premiums for eligible ADAP clients.

- On July 30, a letter was sent to all ADAP clients who are enrolled in a Medicare Part D plan, but not enrolled in the MDPP Program. The letter included information regarding the MDPP Program eligibility and benefits, including payment of Medigap premiums and outpatient medical out-of-pocket (MOOP) claims.
- ADAP enrollment workers received an MDPP Program client brochure and a set of Frequently Asked Questions, to assist in answering program questions from clients.

Strategy M: Improve Usability of Collected Data

In August, OA provided each local health jurisdiction specific data on the nine of twelve Integrated Plan Objectives that allows for analysis at the local level. In addition, an overall summary of local data was released to the public via the OA website. This also impacts Strategies D, E, F, G, and J.

Strategy N: Enhance Collaborations and Community Involvement

On October 23-25, 2018, OA will host a California Planning Group (CPG) meeting in Long Beach, California. This meeting will provide OA staff and CPG members an opportunity to share updates, provide feedback, and conduct CPG business. The meeting is open to the public and there will be an opportunity for public comment. Strategy O: Further Leverage Existing Resources to Better Meet the Needs of People at Risk for and Living with HIV in California

The CDPH, Centers for Infectious Diseases has commenced planning for the integration of the OA and the STD Control Branch into one, new division. A planning team is actively working on a proposal that will be submitted to CDPH for approval in December 2018.

OA Budget and Legislative Updates

The Governor signed the California budget on June 27. Accompanying the budget bill is a trailer bill with language that implements the budget items. Two important things were changed for OA:

 The PrEP-AP was changed to add coverage for Post-Exposure Prophylaxis (PEP), include coverage for minors over age 12, and cover more services for PrEP and PEP for people with and without insurance. CDPH's authority to certify Syringe Exchange Programs (SEPs) at the state level was set to expire at the end of 2018. The trailer bill language extended OA's authority indefinitely to certify these programs. The bill also made some changes that will enable programs to make changes after they are certified.
