- 6. HCAP Annual Report—Stephen Spano
 - Stephen Spano reviews the HCAP Annual Report '21-'22.
 - Spano notes the difficulty with running reports due to a change in reporting technology, emphasizing that no data was lost and security was a high priority.
 - Spano breaks down the services by top issues, top service categories, top services rendered and top outcomes.
 - Spano finds that there was a shift in service categories from previous years, a shift toward using HCAP advocacy to improve quality of care over various service categories and that participants continue to require referrals to services.
 - Spano lists client successes around permanent housing, adequate subsidy, appropriate support and how HCAP has the ability to support the client long-term.
 - Updates regarding the changes to RCFCI system of care.
 - Spano summarizes client challenges: housing vs. help, and mental health and substance use disorders, and aging with HIV/AIDS.
 - Spano reviews the need for Intensive Case Management (ICM).

- CS Perez reviews the needs assessment '22 for PLWH: Trans folk.
 - Primary medical care, housing and mental health services were the main theme of discussion.
