 would like to see in the Federal update.
 - o CM Adams finds them useful, but notes things are changing so fast right now.
 - CM Knoble says the information is useful but presented in a way where they don't retain any
 of it. They note a lot this has to do with their own personal learning style.
 - CM Jewell says he is normally just reading information that is coming from the newsletter but will try to paraphrase the information in a way that makes it more accessible.
 - o CS Molnar wonders if it should be in a different format. He suggests having a handout which can also be projected at the Full Council meetings and that CM Jewell can paraphrase from.
 - CM Lin speaks to some confusion around the concept of appropriation and the legislation at hand. She suggests slowing down and sharing some of the story behind it might be helpful for those that don't live and breathe policy work.
 - o CM Branzuela agrees with other folks and says she's very interested in the process.

- CM Le says it's helpful to have the information on paper and have it summarized so folks can read along as CM Jewell reviews the information.
- CS Molnar provides more in-depth suggestions about what the presentation could cover and provides a sample overview of what could be covered.
