8. Carry Forward Allocation - VOTE

- CM Hutchcroft explains that this year's Carry Forward is significantly less than previous years. Half of the amount we do have is recommended that it go to Emergency Financial Assistance Grants (EFAG). This would be used for housing, rent, etc. Since the pandemic began, folks have had a greater need due to covid and this recommendation would help alleviate that. A specific amount of this EFAG is being allocated to Senior Client's needs such as hearing aids, etc. The other half will go to Client Incentive Vouchers that could be used for client's food necessities and take-out as the pandemic has made it harder for some clients to physically get food.
 - Question from CM Chitty- Do we keep track of the people who use these funds? Is there a
 way that people are finding out about these programs?
 - CM Hutchcroft answered that as long as they are Ryan White eligible then they are Ryan White clients.
 - CS Molnar suggested CM Chitty that he ask CM Gonzalez whether through email
 or at Full Council since he is currently knowledgeable about Kaiser and their
 interaction with the Ryan White system of care.
