7. Carry Forward Allocations-Beth Neary

- Beth Neary reviews the Carry forward funds:
 - o Emergency funds: 350,00

o Food: 314,390

o Tech support: 120,000

- o One-time website re-design and resource guide: 30,000
- o One-time support for additional legal services interns: 20,000
- o Client incentive vouchers: 227,429
- CM Davenport asks about the process about how agencies will then receive these funds.
 - Neary answers once the proposal moves through all the committees, it will go to the funders approval, then a reach out to each of the service providers in each of the service provider categories to see if they still have the capacity to accept the funds.
- CM Hernandez asks about the 30,000 from last years carry forward for Tech support.
 - Neary answers that only one agency was able to accept based on time constraints last year.
 - CM Hernandez expresses concern around funding technology that may become obsolete in time.
 - Neary comments that there is some expected waste of technology being purchased but research has gone in to see what has been successful. Neary answered some agencies were prepared to spend money accordingly.
- CM Hernandez asks how are agencies responding to potential carry forward funds.
 - Neary answers that one organization was ready with a list of tech items that would cost \$20,000. Other agencies may have felt that there wasn't enough time to spend the funds, were unresponsive or were not reached out to.
