1. Introductions

The meeting was called to order at 3:01 pm by CM Sullivan. Everyone introduced themselves and quorum was established.

6. CHEP and HHS Updates - VOTE

- CHEP Update – CM Knoble
 - Moving forward CM Knoble will start working on having a written report for folks with the updates. The health access points that they were funding for the next 5 year cycle are still going through negotiations with community based organizations.
 - They had a successful meeting for the ETE efforts last week.
 - CM Gonzalez asked if the council can get a presentation of how to utilize pandemic protocols and share that information?
 - a. CM Knoble answered that it is on the agenda already.
- HHS Update – CM Blum
 - They did get their notification of funding for RWPA and they did get an increase in the vicinity of \$300,000. Just this week they got their notice of HRSA for funding and also received a 5% increase.

- Community Engagement Committee Update – CM Sullivan

- The COLA was discussed and the needs assessment is in progress. Stephen Spano joined that meeting where he touched up the topic of RCFCI's again becoming an issue once more. CS Clark was bid farewell.
