Minutes

1. Introductions

The meeting was called to order at 3:10 pm by CM Sullivan. Everyone introduced themselves and quorum was established.

2. Review/Approve February 20th, 2025 DRAFT Agenda – VOTE

- 5. Public Comment
 - o None.
- 6. Committee and Work Group Reports VOTE
 - Community Engagement Committee Update
 - CM Sullivan provides an update on the HCAP report shared by Stephen Spano. He highlights a case in which a provider of a residential substance use facility raised an issue, which is possibly jeopardizing someone's housing stability. HCAP met with the client and is still awaiting a response from the service provider. He highlights another case in which a client needs urgent dental surgery and is experiencing pain and infections. HCAP has advocated for the client, but the soonest the service provider could schedule the client was in May.
 - ♦ CM Flores asks if the client who needed oral surgery is doing well.
 - a. CM Sullivan notes the client is still trying to get a sooner date.
 - **i.** CM Flores offers her support since she has experience with a similar situation.
 - CM Sullivan provides an update on the COLA, noting that outreach is still underway. He adds that they are taking a new approach to outreach with new flyers and sending the new flyers to organizations that were suggested by council members.

- CM Sullivan provides an update on the Needs Assessment, which will focus on folks 65+ who are living with HIV. He reviews the Needs Assessment research that Council Staff did and provides an overview of the data.
- o Council Affairs Committee Update -
 - CM Adams updates the group on the Co-Chair elections and notes both he and CM Lin were elected as co-chairs of the Committee. He notes the Committee reviewed the Ending the HIV Epidemic (EHE) update that was provided by CM Knoble.
- Membership Committee Update
 - CS Perez updates the group that the Committee interviewed a potential applicant who
 would fill the Ryan White Part D appointed seat. The Committee reviewed CM
 Geltmaker's exit interview as this will be his last month with the HCPC. Additionally, the
 Committee reviewed the term limits portion of the Policies & Procedures (P&P) for the
 Council.

 - ◆ CS Perez states that an excused absence is an absence that is communicated in advance for things such as vacation or illness. An LOA is a two-month consecutive absence.
 - CM Parada notes that the "Membership Renewal" P&P has gendered "her/his" language and asks if it can be changed to be more gender neutral.
 - ♦ CS Perez says they can make the language gender neutral.
