6. Survey Tool

- The work group continued to review the needs assessment's base survey and tailored it to the target population.
- The group included skilled nursing/respite care to the "What best describes our living situation?"
- CS Jordan noted that he added the question "Have you ever exchanged sex for shelter?"
- The group chose to move the question "Are you currently homeless, lived in a shelter or in transitional housing?" to earlier in the survey.
- The group discussed adding a question that asks "Are you part of a program that helps you pay for your rent?" instead of a question about specific subsidies.
- The group discussed moving the question "How long have you been in this situation?" to go after "What best describes your living situation?"
 - The group added 3 years as an answer option.
- The group included the question "If you did not check homeless in question 17, have you been homeless in the past?"
- The group removed the question about being diagnosed with a mental health condition and what type of mental health care you have received, as it was more pertinent to the mental health needs assessment.
- The group added the question "Are you currently or have you in the past experienced mental health challenges?"

The group discussed leaving in the question about receiving culturally competent care.
