### 5. Public Comment

- Bill Hirsh spoke to budget advocacy efforts.
- Beth Gotti spoke to the FC2 internal condom. They are reaching out to community-based organizations to distribute FC2 internal condoms. She invited folks to approach her during the break for more information.

- 7. Membership Update- VOTE
  - The Council voted on two applicants for membership.

### 9. SOA Update

- CM Andrews provided the SOA update, including:
  - Strategy A: Improve Pre-Exposure Prophylaxis (PrEP) utilization
  - Strategy D: Improve Linkage to Care
  - Strategy J: Increase Rates of Insurance/Benefits Coverage for PLWH or on PrEP
  - Strategy L: Increase and Improve HIV Prevention and Support Services for People Who Use Drugs
  - Strategy N: Enhance Collaborations and Community Involvement
  - Strategy O: Further Leverage Existing Resources to Better meet the Needs of People at Risk for and Living with HIV in California
  - CM Pearce spoke to ADAP coverage. Do you have a sense of people who are disqualified and dropping out?
    - Nicole responded that she will get back to everyone.
  - CM Jewell inquired: could you tell us more about the client portal?

• Nicole responded that we thought it'd be helpful for people who are submitting forms, instead of going into the office then they could extend their eligibility online rather than in person.

## **10. Integrative Health Analysis Report**

- CM Lee-Miyaki presented on homelessness cases at PRC, including:
  - PRC Services
  - Housing Planning Program
  - Partners
  - HPP Goals
  - Demographics
  - Housing Outcomes
- CM Chitty asked why people lost housing. What was the follow up like?
  - CM Lee-Miyaki responded that they're still part of our programs. There were roadblocks in their lives that made it hard to stay housed.
- CM Cabangun spoke to the strategy about motivating clients in a client-led way.
- CM Sutter inquired if it was more effective to spread services across multiple providers.
  - CM Lee-Miyaki responded that it was about making sure folks were using time and resources accordingly, i.e. spending roughly equal amounts of time with each client.
- CM Matthews noted the 26 participants in the study—what were the demographics?
  - CM Lee-Miyaki will find out and send it to council.
- CM Cooper asked if PRC will be able to provide apartment rather than SROs.
  - CM Lee-Miyaki spoke to the current housing crisis and some success at PRC. PRC doesn't have the financial resources to provide apartments at this time.
- CM Bright spoke to his personal experience with SROs and income eligibility.
- Co-chair Goodwin is curious about ineffective monetary incentives.
  - CM Lee-Miyaki responded that \$25 gift cards are really effective at baseline, but less so after 6 months or a year.
- Public Comment: Bill Hirsh noted that we are very interested in housing opportunities for our clients. There is confusion around the assessment tool and coordinated entry.

# 11. Council Member Panel

- Ed Chitty, T.J. Lee-Miyaki and Eric Sutter were featured on the Panel.

# 12. End the HIV Epidemic Report

- CM Blum updated that council on the End the HIV Epidemic (ETHE) Funding, including:
  - ETHE Plan for HIV Care
  - Application Background
  - ETHE Key Strategies
  - Building on Work that's already been done
  - San Francisco Application

- CM Jewell asked why San Mateo and Marin weren't included.
  - CM Emerson noted that Marin is not a jurisdiction that would be eligible under this funding.
  - CM Goodwin added that there were specific counties carved out to be eligible for this funding.
- CM Matthews spoke to the national strategy and the demographic breakdown in regards to the black community living with HIV.
  - CM Blum replied that they are interested in reducing those disparities. People have different identities and can show up under different demographic categories.
- CM Bright spoke to the role of education in viral suppression. Will any of the funding go towards education? Is any of the funding going towards supporting local clinics serving atrisk folks?
  - CM Blum responded that the education happens through agencies, case managers, health care providers, etc... This is an allowable expense, but the application doesn't specifically address education.
  - CM Bright added that education should also be given to providers.
- CM Lin asked: how long we have been anticipating this federal money?
  - CM Blum responded that this funding came as somewhat of a surprise. The turnaround time was very quick.
- Co-Chair Gonzalez asked if the report will be available for the council to see.
  - CM Blum responded that they would like to share it when possible.
- CM Shriver clarified that clients must be Ryan White eligible in order to qualify for this funding.
- CM Blum noted that the funding could pay for hotel rooms, housing case management and housing subsidies, but not to build more housing.
- Public Comment: Bill Hirsh spoke to the need for housing in the city. It would be great if some of this funding could go towards housing.

- CM Pearce spoke to the lack of transgender diagnoses in the last 3 years.
  - CM Emerson responded that the data on gender is somewhat unreliable.
