# Minutes

- Call to Order and Roll Call. Introduction of Members of the Public. The meeting was called to order at 3:35 pm by Co-Chair Knoble. Roll was called and quorum was established.
- Review and Approve January 27<sup>th</sup> 2020 DRAFT Agenda VOTE The January 27<sup>th</sup> 2020 DRAFT Agenda was reviewed, amended and approved by consensus.
- 3. Review and Approve November 25<sup>th</sup> 2019 DRAFT Minutes VOTE

The November 25<sup>th</sup> 2019 DRAFT Minutes were reviewed and approved by consensus.

- 4. Announcements
  - CM Discepola announced his resignation from the Planning Council. He thanked everyone for all of the work they are doing. He would like to continue to be involved as much as he can.
  - CM Antonetty noted that the Department of Homelessness and Supportive Housing is moving into new offices at 440 Turk- there will be a new access point as well.
  - CM Knoble announced two job openings with CHEP.
- 5. Public Comment
  - Bill Hirsh spoke to budget advocacy. They are reaching out to leadership of the council to make sure we are in alignment around budget advocacy.

### 6. Council Staff Update

- CS Molnar noted that Charles Siron and Mike Shriver are out on Leaves of Absences.
  - He added that the February meeting will start an hour later due to scheduling issues—it will take place from 4:30-7:30pm at 25 Van Ness, room 610.

# 7. SOA Update

- CM Andrews provided the SOA and ADAP updates, including:
  - Strategy A: Improve Pre-Exposure Prophylaxis (PrEP) utilization
  - Strategy D: Improve Linkage to Care
  - Strategy J: Increase Rates of Insurance/Benefits Coverage for PLWH or on PrEP
  - Strategy L: Increase and Improve HIV Prevention and Support Services for People Who Use Drugs
  - Strategy N: Enhance Collaborations and Community Involvement
  - Strategy O: Further Leverage Existing Resources to Better meet the Needs of People at Risk for and Living with HIV in California
  - CM Knoble asked if SOA is looking for feedback from county partners in regard to the statement on the syringe programs.
    - CM Andrews responded that the prevention team is heading that initiative and they are getting feedback.
    - CM Knoble added that we have heard there has been significant community pushback. He encouraged council members to weigh in.
  - CM Andrews added that as of today, Dr. Marisa Ramos has officially been appointed as the Chief of SOA.

# 8. 2019 Year in Review

- CS Molnar provided an overview of the Council's work in 2019. He went over a summary of Council meetings month-by-month, including:
  - Presentations (including annual reports, presentations to the council)
  - Meeting evaluation scores, quotes
  - New members elected
  - Public Comment
  - Committee and council cochairs, CM Chitty (Membership), CM Sutter (Community Engagement), CM Adams (Council Affairs), CM Gonzalez (Steering), spoke to their experiences with their respective committees and full council.
  - CM Knoble spoke to the Council Touchpoint conversations from 2019.
  - The council thanked him for his presentation.

### 9. FPL Income Requirement- VOTE

- CM Goodwin spoke to the proposed increase to the FPL Income Requirement.
- CM Jewell asked why they are preferring to increase rather than through private practice.
  - o CM Goodwin—there are a lot of people who like the level of service

- CM Chitty commented that many clients are coming in to ask about private practice.
- CM Pearce suggested getting feedback throughout the year to dedicate rollover funds.
- CM Jewell noted that we are losing HIV specialists in private practices.
- CM Lee-Miyaki asked for clarification on the two service categories having trepidation with the increase.
  - CM Goodwin responded that one was food. He will follow up on the second one with staff.
- MOTION: CM Thomas moves to approve the move to a 500% FPL.
- CM Jewell seconds the motion.
  - CM Emerson commented that we are moving to 500% in Marin. They do cap FPL at specific levels for different service categories.
- MOTION APPROVED by roll call vote. See column (1) for vote breakdown.

  - Thank you
  - CM Thomas commented that this is important work to be doing. It's frustrating to see women dealing with similar issues as they were many years ago.
  - CM Sullivan spoke to his personal experience and the reality of these issues in the Tenderloin.
  - CM Hernandez asked if the Women who Use Substances COLA included just cisgender women.
    - CS Clark responded that it included both cisgender and transgender women.
  - CM Pearce asked if there were repeat clients in the different COLAs.
    - CS Clark responded that there were no repeat clients.

- CM Harkin noted that he has heard many of these issues brought up by clients. It is important work.
